- All requests that are over 30 days old that have not provided the additional information requested will be automatically denied going forward.
- If you make an unapproved change, this will result in a violation on your account, and will be addressed further.
- All requests are going through the website. If you plan to make a change, please ensure your account is set up on the website, and that you check your email consistently for follow up on any requests you have submitted.



Update on Requests received

- Since inception of the website, the following requests and decisions have been processed:
 - 40 approvals
 - 10 denials
 - 9 requests have expired due to additional information not being provided within the needed time frame.
- Should you submit a request and receive a denial, you are welcome to request a hearing from the board of directors to review your request.



Enforcement

- All violations of the covenants are followed up on within the avenues available to the board.
- If you have a violation that continues to be outstanding for longer than 30 days, the board will pursue further action regarding the violation of the covenants.
